

# Policy: Property Management – Asset Classification

### 1 Purpose

The purpose of this policy is to describe FNAL's method for categorizing governmentowned personal property.

### 2 Scope / Applicability

This policy applies to all LPC personnel and operations.

### 3 Policy

FNAL categorizes property per definitions of personal property in accordance with 41 CFR 109-1.100-51

- 3.1. Property categorization is a best practice which ensures effective utilization of government resources, supports the research program, identifies custodial responsibility for specific property items, allows periodic review and evaluation, facilitates disposition and provides clear documentation of all actions relative to the use of government property assigned to the Laboratory.
- 3.2. Assigned classifications include:
  - 3.2.1. Equipment
  - 3.2.2. Sensitive
  - 3.2.3. Stores
  - 3.2.4. Precious Metals
  - 3.2.5. High Risk Personal Property
  - 3.2.6. Other Accountable Property
  - 3.2.7. Administratively Controlled
- 3.3. All assets receive an identification tag with barcode and indicating "US Government Property". Unique identifiers are adhered when appropriate, and all assets are managed within the computerized asset management system.

## 4 Responsibilities

- 4.1 **Property and Infrastructure Requirement Assurance System Owner** approves this policy, identifying necessary resources and overseeing consistent laboratory compliance.
- 4.2 **ISD-Logistics and Property Control Department Head** is responsible for implementing



and managing changes to this policy by assigning appropriate resources.

4.3 **FNAL Property Office and Receiving Department** are responsible for following the guidance in this policy.

# 5 Definitions

- 5.1 *Personal Property* Property that is owned by the government, in custody of the Laboratory, both equipment, materials and supplies, exclusive of utilities and real Property.
